



Shirley Igo Advocate of the Year Award

Criteria and Application

2008 marked the passing of one of PTA's greatest child advocate leaders, PTA national president Shirley Igo (2001-2003). Shirley was a model of public service and volunteerism throughout her life. She was an impassioned and compassionate leader, dedicated to moving PTA forward and committed to ensuring that others would follow.

To honor Shirley, PTA will present an annual award to one individual who most exemplifies the qualities that made Shirley a true advocate for all children. The person chosen to receive this award will receive an all-expense paid* trip to the 2009 National Legislative Conference and be recognized at an awards ceremony on Capitol Hill on March 12.

Nominations may only be submitted by someone other than the nominee. The nominee must be a current PTA member whose unit/council/district/state is in good standing. Additionally, the nominee's advocacy efforts must have taken place within the last five years and documentation of these efforts must be provided.

Nominations will be reviewed by National Legislation Committee and a panel of Shirley's friends and fellow advocates will select this year's award recipient. Please see the application criteria below for details on how you can nominate someone you believe is deserving of this award.

Award Application Requirements

Nominations may only be submitted by someone other than the nominee. The nominee must be a current PTA member whose unit/council/district/state is in good standing. The nominee's advocacy efforts must have taken place within the last five years.

Complete application packets will include:

- Completed nomination cover sheet
- A brief narrative (maximum total length of three (3) double-spaced pages) providing the following:
 - Why do you believe the nominee is deserving of this award.
 - Describe how the nominee exemplifies the qualities listed above.
 - Provide at least one example of an advocacy related issue that the nominee worked on within the past five years, detailing how the nominee served as an advocate, leader and mentor.
- Supportive documentation: two (2) examples of work done relating to the examples given in the brief narrative.
- Optional: resume of nominee
